President's Message



We look back over the last fiscal year while also keeping an eye on the future. Beginning on Sept. 12, 2011, *Providence* celebrated its 60th birthday throughout the school year. On the actual day, some of our alumni who were students in the first class in 1951 came and served birthday cake in the cafeteria.

We commemorated the milestone by designing a special photograph interweaving our current freshman with the first freshman on their first day of school.

We also recognized several of our legacy families and highlighted some of our history in the eVISION newsletter. Reading over those history pieces, it is obvious how so many things have changed over those 60 years. What hasn't changed is our commitment to excellence in a family atmosphere.

Sixty years ago, the only technology schools had were the typewriters in the typing classroom. The *Providence* classes of 2012-2013 will employ one-to-one technology with each student bringing their Apple iPad to class. Foreign language students can record their pronunciation and email it to the teacher, and history students can view historical places real-time and take virtual tours through museums. E-books in the math class allow students the opportunity to work with graphs, adjusting the

slope and the equation at will. Amazing. *Providence* made this possible by foregoing the 2012-13 book rental fee and allowing parents to buy an iPad for their student instead.

This innovation along with our commitment to excellence has allowed us to remain a vibrant school and community where we continue to inspire faith, empower hope, and strengthen love, all through exemplary Catholic education. In the midst of the continuing economic downturn, *Providence* has held its own with enrollment. The school has no debt, and thanks to the generosity of the parishes and the annual support they give us, we are able to offer lower tuition to those who belong to our parishes. We have been able to assist 40 percent of our families with financial aid (merit and needs-based), and we are embarking on a new capital campaign to help build an endowment fund to continue to keep tuition affordable. We must also replace the old bleachers in the Larkin Center gymnasium, remodel our old 1950s era kitchen, and replace the football field restrooms and concession stand.

God is indeed good. *Providence* excels in so many areas and all through the lens of our Catholic faith. The future is bright.

For more than 60 years, *Our Lady of Providence Jr.-Sr. High School* has been an outstanding choice for educating students in this area. Our alumni number more than 8,000 from 57 graduated classes and have gone on to become teachers, priests and religious, doctors, lawyers, business owners and managers, judges and mayors, and even Indiana attorney general and superintendent of education. Even more impressive, a number of our alumni are part of second- and third-generation *Providence* families.

The continuation of *Providence High School*, while always challenging, has been accomplished as a result of the sacrifice and hard work of many parents—along with the support of the New Albany Deanery parishes. The financial contributions of alumni and friends over

the years have also been a sustaining force for the school. Still, costs rise each year, creating an ever greater challenge for financial stability and sustainability. New and additional funding is needed to keep *Providence* progressing, whether supporting its outstanding faculty or continuing to upgrade the facilities or technology. To help with this funding, a special endowment program has been initiated in recent years.

This program establishes an endowment for each graduating class. Each class organizes its own fund drive to raise the minimum of \$5,000, and the funds are kept separate by class and managed by the Catholic Community Foundation in Indianapolis. Twenty-seven classes have begun their endowment fund, and 13 have reached their minimum and are now permanently endowed.

The endowment program is a safe, long-term source of funding for *Providence* and ensures that the principal of the funds cannot be spent. Only a portion of the fund's earnings can be used for items such as tuition subsidy or facility improvements. If we meet the goal of having an endowment for each class, the funding from this program can really

make a difference.

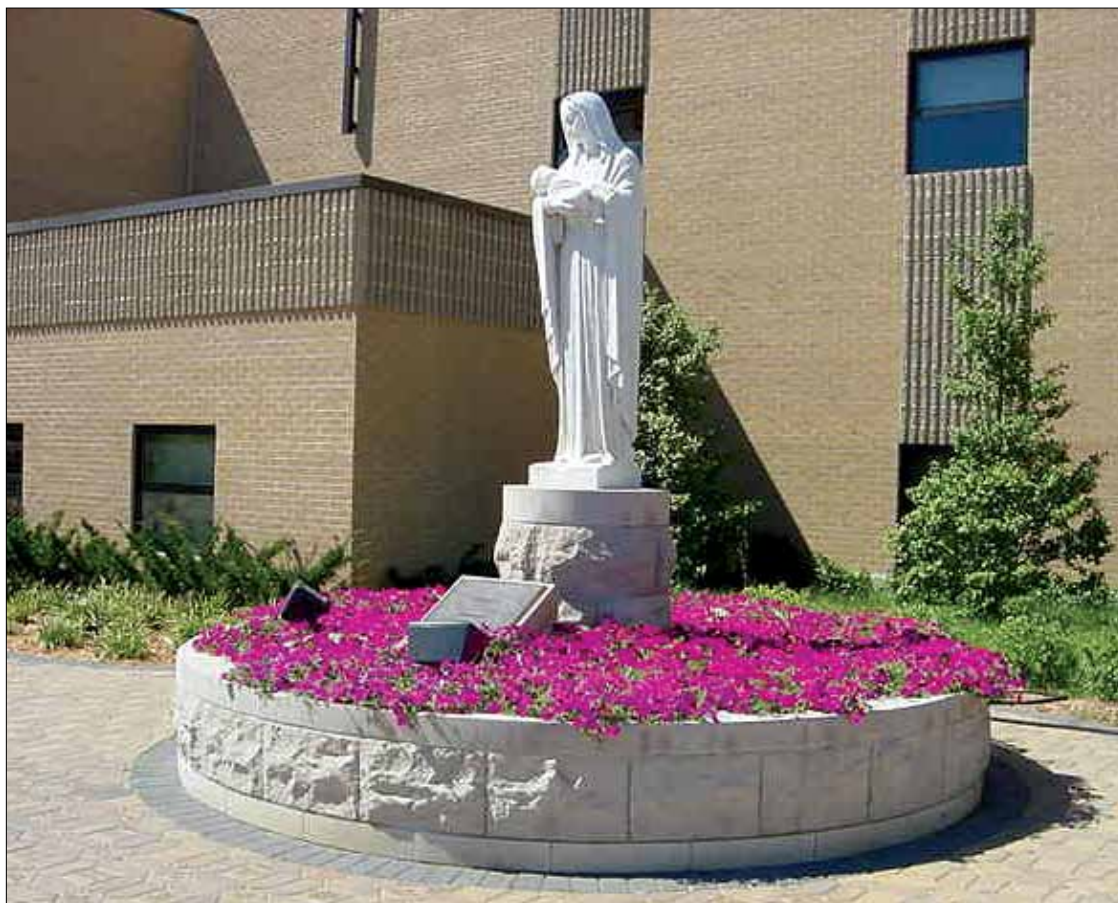

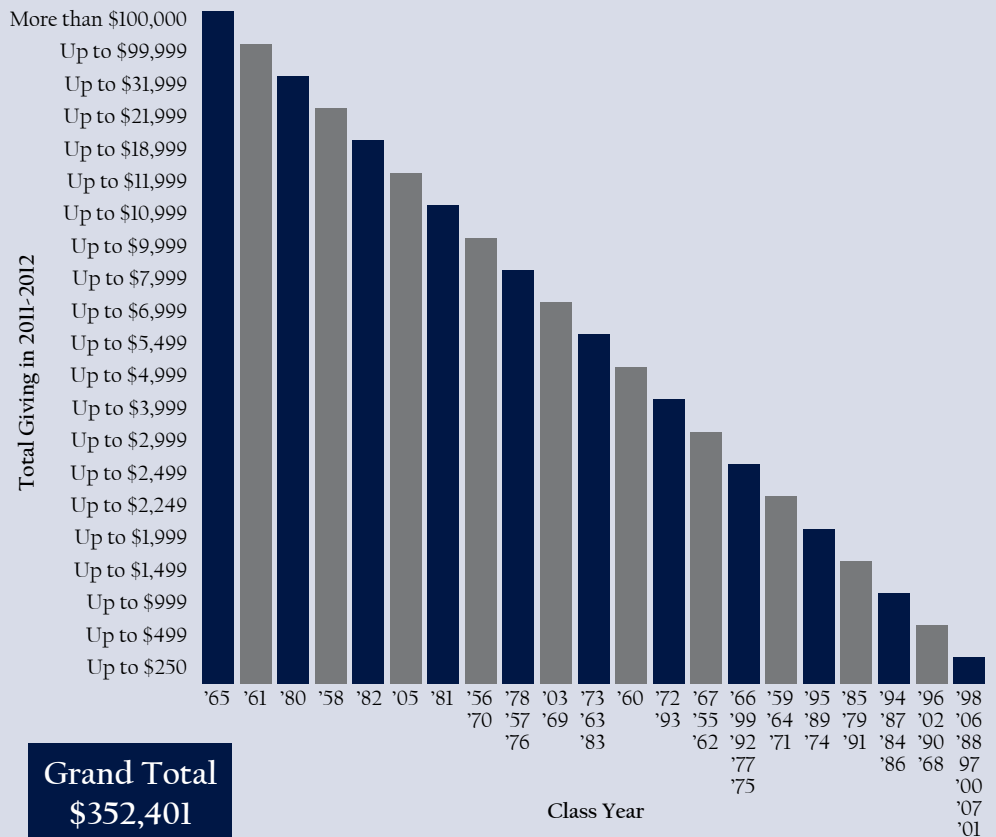

The Legacy Continues

This edited article originally appeared in the July 18, 2012, issue of the e-VISION.

Throughout the 2011-2012 school year, Providence celebrated its 60th anniversary with several events. The e-VISION email newsletter profiled various legacy families who have helped Providence continue its mission with two or three generations of students. The series ended with this article, which looks forward to the next 60 years as alumni with small children plan the course for their future Pioneers.

Katie Butt Beckort '95 came to Providence as a seventh grader because her mother, a teacher, wanted her to get a good education, even though the family was not Catholic and had no relatives attend Providence. The experience impacted her so much that Beckort recently joined the Catholic Church and has enrolled her oldest child, Blaine, 5, in kindergarten at Holy Family School. It was a hard sell for her husband, Brian, who went to public school and is not Catholic, to commit to Catholic education for their three sons (including Duke, 4, and Henry, 10 months)—until she showed him the recent ISTEP results comparing schools in their district to New Albany Deanery schools.

“As a whole, it was unbelievable comparing our options of public versus Catholic schools,” she said. But the overall experience is one Beckort wants for her children. “An education like that combined with faith experiences on a daily basis makes for a great experience.”

The Beckorts are planning for their children’s education by focusing on saving for college with a College Choice 529 plan.

Previously, they contributed to a Coverdell Education Savings Account, which allows for tax-free growth and withdrawals for elementary, high school, and college expenses.

Greg Nash '92 also is a first-generation Providence graduate (following older brother, Scott '84), but his wife, Christy (Geswein) Nash '96, comes from a legacy family that includes its first third-generation Providence student. The couple already is planning ahead for their three children, Foster, 5, Cooper, 4, and Felicity, 6 months (who will someday be classmates of Beckort’s children). The older two attend St. Mary of the Knobs School, and all three should graduate from there as well as Providence.

Planning ahead for their children to attend Providence “was a pretty easy choice for us because we both value Catholic education,” Nash said. “I feel strongly that I would not be where I am today

professionally, socially, or spiritually if I hadn’t attended Providence. I want to offer my kids the same opportunity to have that positive experience.”

In order to save for their children’s Catholic education, the couple contributes monthly to a “Providence fund” in addition to their children’s college funds.

“We tend to view the perceived ‘cost’ of attending Catholic schools in general, and Providence specifically, as more of an ‘investment’ in our children – just like our parents sacrificed and invested in us,” Nash said.
